FOOD VENDOR GUIDELINES & NOTFICATIONS:

Food Vendors are required to have Thurston County Health Department certification. Vendors must display permits according to Health Department regulations. For more information, please contact the Health Department at 360-867-2667.

Food Vendor booth space is outside. Food Vendors must supply cooking equipment and all booth display needs. Tables and chairs will not be provided to vendors.

Booths must be completely set up by Saturday, July 8, 2023, by 10:00am. Set-up time will be between 6:30am and 10:00am on Saturday morning.

Electricity will be provided based on the information provided on the Food Vendor Application.

Booth must be ready for business, with all vehicles removed from the vendor area by 9am on Saturday.

Vendors must remain set-up until 6 pm, even if you run out of food or products. Vendors are not able to tear down early and must leave their spaces and as they found them.

Washington State Food Service Regulation WAC 246-215-120 Sanitary Facilities and Control states: *"Food service establishment owners shall dispose of all liquid waste including gray water, mop water, and ice melt into an approved on-site sewage disposal system or in another manner approved by the health officer."*
